## IS IT STILL WINTER??

I'm not sure where this season is going or how it will end, yet all I can say is we haven't had this poor of a season in a long time. Due to the poor snow conditions, I was interviewed by a News Graphic reporter named Jim back in January on how this lack of snow affects our Club. The article appeared on the back page of the main section on Thursday, January 19, 2012. (A copy is also posted on our website.) Jim was surprised to hear me say "we need more snow to open our trails". He was under the impression that when we got snow and the ground was covered, we rode our trails. Informing him of our trail open requirements and once I told him of the possible damage that would be caused when we have too little snow, he got a better understanding. Since Jim had never been on a snowmobile, he got a crash course on the ins and outs of our sport. Especially with our volunteers and what we do each fall with trail work, each winter with grooming and then spring when we remove our trails. Hopefully, his positive spin of our sport will give us a boost considering how our winter is going.

And talking about our sport of snowmobiling, I have heard that the conditions of the trails up north are not too bad considering the weather. One couple had gone upto their cabin in Elcho to go snowmobiling this past weekend. From their discussion, they stated as long as you stayed north of Antigo and Elcho, you had good riding. Trails and the lakes they crossed were decent and they had put on 120 miles on Saturday. Even on Sunday when they went out for breakfast and rode around, the trails were still in good shape.

Another couple went up on the Ski-Doo weekend (thru dootalk.com) to the Minocqua area and were on their own on Friday, so they hit St. Germain and the surrounding area. Trails were also in pretty good shape, yet the weekend was still young. Saturday, they headed out with a group of 47 Ski-Doo snowmobiles and 51 riders, and they headed north and west of Minocqua. Trails were in good shape on Saturday as well and they put on 125 miles. The railroad grade was probably the worst section of trails; the groomers had enough snow to keep the railroad grade in good shape, yet the traffic kept the gravel churned up in the snow. Sunday had just the two of them and they headed out and put on 80 miles. Light traffic on Sunday lead to decent trail conditions.

If anyone has gone up north snowmobiling, I'd like to let our Club members know via our newsletter or Club meeting. Let me know where you went, number of sleds and riders, mileage per day or total, where you snowmobiled plus trail conditions. Any good areas to pass on to our Club members is a definite plus for snowmobiling. Especially with the unusual winter season we are currently experiencing.

As of now, I have used up my allotted space once again and need to wrap this up and move on. So, till next month, keep your track on the snow and remember, "United We Trail, Divided We Fail"......

When conditions are right, please remember that we need at least 6" of snow on the open fields and 32 degrees Fahrenheit or colder. Plus, remember to call the snowmobile sno-phones before riding. Also, please play it safe and stay off lakes and rivers until they are frozen; we need more nights with colder temps in order for the ice to freeze nice and solid (remember, if there are no tracks on the lake or river, there is a good reason why).
