# **SNOWMOBILE SAFETY COURSE**

In December, we had 16 students successfully complete our Wisconsin Snowmobile Safety course held at the Mequon Police Department. The students completed eight hours of class room study that included snowmobile nomenclature, riding positions and hand signals as well as being prepared clothing wise plus out on the trail, first aid, courtesy, ethics and snowmobile laws. A snowmobile was also brought into class for hands on training. Upon graduation the students can legally operate a snowmobile with parents permission (if a minor) and the certificate is reciprocal throughout the United States. Thanks to our instructors Dennis Guttmann, Steven Graff, Kathy Monroe and Mike Wilhelme for conducted this class.
