SNO-FARIs

Our first Sno-Fari is approaching quickly. It is to take place on the first weekend in February. Chris Bumpke is heading up this trip and the dates are February 1st thru 3rd, 2013. As of December's Club meeting, Chris did not have anyone signed up for this trip. The plan at this time is to stay at the AmericInn in Silver City, Michigan. There were ten (10) rooms blocked off under Monticello (seven (7) with queen beds and three (3) with king beds) and the rate is \$80 per night plus tax (you need to mention Monticello when reserving your room to get this rate; otherwise it is \$103 per night). If you plan to get there a day or two early or even stay a day or two later, let them know and you'll still get that \$80 rate per night.
