OUR ANNUAL FUND RAISER IS APPROACHING...

By the time you receive this newsletter, the 2015 Ozaukee County Fair will be right around the corner! The fourth of July is past, and now the temps outside are starting to get hot, so the Fair must be getting close. Anyway, dates for this summer's Fair are Wednesday, July 29 thru Sunday, August 2nd. Set up will take place on Monday, July 27 and Tuesday, July 28 starting at 6pm (or earlier); teardown will start around 7pm on Sunday, August 2 (depending on the crowd) and Monday, August 3 for the teardown and cleaning of our cookshack. One note, given the weather allows for our tent to go up by Friday, July 24, we are planning on getting our trailers and cooler truck down to the fair grounds on Saturday, July 25. Plus, there is some prep work we need to do to get ready for Monday night. We will be looking for some volunteers to help out for the Saturday morning set up; we'll call, text and/or email letting you know of our plans.

As you all know, our food and beverage tent is our one and only fund raiser for the year for our Club. Because of this, we have in the past been able to purchase a newer Tucker and pay off the loan thirteen months ahead of time plus we still have enough profit left over each season to be financially sound. That is a pretty awesome feat for a non-profit and 100% volunteer Club to accomplish! So once again, we will need as many volunteers as possible to make this year's Fair another success! And as you read further, we are in the market for a tractor to use for cultimulching, so another profitable fair is definitely needed. Included in your newsletter is our work schedule; please check it out as there are plenty of areas where we need help, especially on the weekend.

Our tent will be located in the same spot as it for the last two summer's Fairs, on the north end of the grounds across from the new Curling/Multi-use building. The vehicles from 5 Corners Truck and Auto and 5 Corners Dodge Chrysler Jeep Ram Trucks will be on the south end of our tent. The recreational vehicles from Cedar Creek Motor Sports should be on the east or north side of our tent, depending on tent location. Once again, we will have live bands playing nightly Wednesday thru Saturday in our tent. Our own Nesco Queen has gotten ten local establishments (so far, two additional ones are on the bubble at this time) to help sponsor our live bands. They are as follows: Circle B Recreation, Grand Ave. Saloon, Juices Ghost Town, Kirchhayn Country Club, the Railroad Station, The Roadhouse, Smitty's on the Edge, Stonewall Pub, The Bridge Inn, and Maxwells. If you happen to stop at these places, thank them for helping us out this summer.

For those tending bar, the legal drinking age is of Today's Date, 1994. No ID, no alcohol; plus, we are only accepting Wisconsin IDs. Plain and simple and this has kept things working smoothly behind the bar for many years.

All workers, since our schedule is light, we are asking you to arrive at least one (1) hour before you are scheduled to work so you can review any changes as well as refresh yourself with our procedures. Also, if you are able to stay an hour past your time, that would really help us out. If you need to change your time or add another shift or cancel, please call Chris "Nesco Queen" Habich. Food pricing for the most part have been held in check, yet we did raise a few items to cover our cost increases. But beer pricing has stayed the same as last year; 12oz. cans as well as cups of beer are \$3.50 each and pitchers are \$11 new and \$10 refills; the 16oz aluminum bottles of Bud Light and Miller Lite will be \$5 each. The other alcohol beverages (Seagram's Wine Coolers and Mike's Hard Lemonade) are also \$5.00 each.

WISCONSIN TRAIL PASS

As of July 1, 2015, all registered snowmobiles in our beautiful state of Wisconsin will require a trail pass in addition to your snowmobile registration. As a Club member in good standing (paid membership), your Club belongs to the AWSC and you have a current Wisconsin registration for your snowmobile, you will receive a discount on the trail pass. Normally, the trail passes cost \$30 each, yet if you meet the above criteria, you'll get your trail pass for \$10 each. We have included a flyer that the AWSC sent to us regarding the four ways you are able to get a trail pass. Plus, the application for the trail pass is on the back side of this flyer if you decide to use snail mail. Eventually, we will have a link on our website that will take you right to the AWSC website for online ordering for these trail passes.

Please remember to obtain your trail pass before riding; penalty if caught without one is \$250. If you have any questions, comments or issues with the trail passes, please feel free to contact myself or anyone of our Board Members via email or phone.
