## APPLE PIE TUMMY WARMERS

2 qts each apple juice & apple cider  
1+1/2 cups white sugar  
4 whole cinnamon sticks  
1+2/3 cups "Everclear" grain alcohol

Mix all ingredients EXCEPT for alcohol in large pot. Bring to boil, then remove from heat and allow to cool completely before adding the alcohol. May be simmered to drink warm or refrigerate to drink cold. Enjoy in moderation and after your sled is PARKED for the day.
