### TRAILS & LANDOWNERS

We have started to contact our landowners to get their permission to once again this season, cross their land with our snowmobile trail. Also, to make sure all went well last season and to correct any issues or problems. Also, we are looking at the re-route south of the Jailhouse and north of Hwy 60 where we got cut off after the end of last season. There will be a little more work to initially put this trail in this fall, yet we'll know more where we will run it after contacting new landowners for their permission. ### **CULTIMULCHING**

We are still in need of a tractor for cultimulching this fall. Inquires have been made to local implement and tractor dealers and Lochen has the best deal, yet there is a minimum cost to this route. Otherwise, if anyone has a tractor that meets the following minimum: 80hp, 8000lbs, 18-4x38 tire size, that we would be able to use this fall, please give Randy Kison or myself a call for more information.

## TRAIL EQUIPMENT

As of printing of this newsletter, our Tucker has had all the filters and fluids changed as well as the seals replaced on the power steering unit (slow leak). All that is left is to grease the idler wheels on all four corners. Snow is approaching and we aim to be ready; the drag is next.

Our ATV has had the oil and filter changed and our chainsaw has been gone thru as well this fall; both are trail ready. Our pole saw had some warranty work done on it this past spring and besides needing to sharpen the spare blade, it too is ready for the trails. Now we just need to give some attention to our brusher; the rear wheel sleeve bushings are worn and are in need of replacement. This is currently in process as you are reading this newsletter.

A hearty thanks goes out to Randy Kison, John Haen, Dan Burback, Deanna Einwalter and Egelhoff Lawnmower Service for the work performed so far on our equipment.

### **TRAIL WORK**

It will be October by the time you receive this newsletter. This means it is time to start trailwork. At this time, we are planning on starting trail work in mid October; please mark your calendars for our work dates as seen below. We meet at the Kison Farm at 7:30am and work until noon; this leaves the rest of the day for our own personal to-do items.
