numbers as well as your AWSC membership number; this number can be found on your yellow AWSC membership card or above your name on the address label of your AWSC magazine. If not, please contact Deanna Einwalter for your AWSC number via email or call her on her cell listed on the front. Remember, every snowmobile that is ridden on any Wisconsin snowmobile trail must have a trail pass (just like riding in the UP) as well as a current registration. One quick note, if you get a trail pass for your snowmobile and then you decide to sell it during the season, your trail pass is valid for the new owner.

LANDOWNERS

We will be calling you (if we haven't already) to obtain your permission to cross your land again this season. Due to the trails never opening last season, hopefully there were not any problems, yet if there were any or if changes need to be addressed, let us know when we call. Also, we have seen a few properties that are either up for sale or have been sold; we will be checking with you on this to determine trail status as well as who to contact for permission to use the land. Thanks in advance for your help with our trails.

TRAIL WORK
