With the high velocity winds late that hit us this fall/early winter, we have had to get our trail work volunteers to go out and remove downed trees in some areas two to three times! It doesn't help when the Ash borer has killed off the Ash trees and they are now at that weak and rotting stage which in turn allows them to fall down at short notice. (Just ask Hibber!!) Yet we do have all ready to go when our next snow hits!

And we were able to open our trails on New Year's weekend for at least thirty-five ish (35+) hours. Our trails did hold up well for the first day and as it got a little warm on Sunday, some of our watery areas opened up and caused a few problems (just ask Jake or Katie!). Unfortunately, we did have an issue with the pond north of Western Ave. late Sunday evening. A snowmobile getting stuck crossing the 18"-24" deep open water and then an SUV got stuck trying to pull it out! This all finally got resolved Monday evening with the help of a wrecker. We have discussed this with the landowner and are working on a solution to keep this from happening again as it usually happens at the start of our season.

On a sad note, a former landowner (owner of the farm where we store our trail equipment) and Randy's mom, Mrs. Lorain E. Kison, has past away peacefully on New Year's Day at 101 years and seven (7) months old. She has been a resident of Lasata for the past number of years and was there when she died. GUEST SPEAKERS

In December, we had two (2) guest speakers at our Club Meeting. Both are Club members and each covered very important topics. First off, thanks to Cal Cummings for covering the Polaris RideCommand app for our "smart phones" (a phone is termed smart, really?). This app is designed to be your trail map using GPS for snowmobiling, ATVing, UTVing, etc., and especially if you do not ride a newer Polaris snowmobile with this built in to the dash. The app is very user friendly and besides showing you the snowmobile trails where you currently are riding (plus city streets), you are able to save your trail ride, see mileage, gas stations, save a map offline (incase you loose the GPS signal) and even find Polaris dealers. (Note: there are more features than what is listed; download it and check it out for more info.) The only issue is this app is only as accurate as the Clubs providing trail info to Polaris. We are fortunate Cal has agreed to keep this app updated (with the rep for this app) so our trails are accurate as possible. It is a free to download from your phone's app store.

Secondly, thank you goes out to Dennis Guttmann for speaking on snowmobile safety.

We can never have enough safety coverage as well as refreshers to help keep us safe while snowmobiling! Dennis covered the basics from going over your sled before starting it each time you ride, hand signals, trail etiquette and trail related deaths from last season. It is surprising what you learn from another person's unfortunate mistake. Plus, as we all age, we all need reminders of the do's/don'ts when snowmobiling!
