ANNUAL FUND RAISER

So with this information, we did a quick poll of the 32 Club members at the March Club Meeting. The question was:

Also, we have installed a dry erase board in the sign shed at the Kison Farm so we are able to keep track of what has been done completely and/or partially. This will help us from forgetting a portion of our trail and causing an issue for a landowner.

So if you are able to help, stop out at the farm and see what we have left to pull. Possible dates to wrap this up are Saturdays April 3 & 10th. Thanks to all helping remove trails this spring!
