## **DEJA VU**

It happened last year on the first Monday of December and it happened again this year (at least in the northern area where Lori & I reside). It snowed and schools were closed. What a way to start off December than with snow and plenty of it as well.

We received roughly ten inches of snow up north here and it was wet and heavy. Good base for our area and perfect for starting out the winter season. With more predicted, please note that our trails do not open until December 15. This is to allow each club in our county to complete their trail installation as well as allow farmers to get their crops picked; continu

to call the sno-phones to find out our trail status. There is a listing of the surrounding counties and their sno-phones plus website on the back side bottom of this newsletter. Call them before riding to ensure that all the trails are open.

Keep your eyes on our local newspapers – <u>The Ozaukee Press</u> and the <u>News Graphic</u> — over the next week or two. We have submitted an article regarding snowmobiling, our club and how we, as volunteers, install and maintain our snowmobile trails. Chris Habich came up with this idea last season because of the snowmobile traffic she saw come thru PDQ. She was surprised how many non-club members believed that the county took care of the all the trail work. As many of you know, this is far from what actually happens. So, we as the Board, decided to help better inform the non-club members and the general public of what we do as a club, and that the trails don't just magically appear courtesy of the county. Since our purpose as a snowmobile club is to promote safe snowmobiling, using the local newspapers is the perfect tool. With an outstanding year last year, and this season off to a good start, putting this in front of snowmobilers is an ideal way to help kick off our season.

Another point for this article is that the DNR's rule of where anyone born on or after January 1, 1986 must successfully complete a snowmobile safety course before renting, purchasing, or just driving a snowmobile in the state of Wisconsin. Most rental places up north started requiring this last year and this year, all are requiring it before renting snowmobiles. Even snowmobile dealers are requiring this when selling new and used snowmobiles. We need to keep snowmobilers safe and informed and this is just one of many ways to do this.

With all this snow, please call the sno-phones often and daily to check trail conditions. Please help us by giving out these phone numbers to those who do not belong to a snowmobile club. Till next month, keep your track on the snow, ride safely and we'll see you on the trails.......

#### **TRAILS**

Saturday, December 6, was our final push to wrap up our trails. We did not have too much left, just some short stints that we couldn't do before deer hunting began. Even with the snow on the ground, we will still finish it up with ATVs. More details at this month's Club meeting.

Please be aware of some trail changes this season. First off, the dead end trail to PDQ has moved east to the tree line (where it ran up till four or five years ago). Second, on the north side of Hwy. 60 across from Circle B, the trail now runs parallel to Hwy 60 on the edge of the field, and then turns north and runs parallel to Hwy I also along the edge of the field. This replaces our trail that ran kitty-corner across the field. Due to the crops in the field this year and at the farmer's request, it was decided this was the best way to re-route our trail. Please help us out by following our trail markers and stay on the marked trail.
