The Tucker and drag have operated really well and we now have our pole saw mounted on the drag so it is with us in case we encounter low branches or a down trees (there is also a chainsaw along for the downed trees). Having this equipment along with is a great asset; the groomer operators are able to quickly cut up the tree(s) or branch(es) and move them off the trail and then continue on grooming.

It was discovered that a concrete hammer drill and a 1-1/2" concrete bit (similar to an ice auger) is the ticket to get a hole into the frozen ground. Once you break thru the frost, you are golden. This is how our guys put trails in the last two Saturdays in December.
