MEMBERSHIP & AWSC

Starting this past summer, all AWSC memberships expired on June 30. Previously, each AWSC membership expired one year from date of renewal which if you think about it, could cause an issue. This new expiration date was implemented by the AWSC because one or two snowmobile clubs in our state took advantage of these renewal dates and were able to skip paying AWSC dues every other year. If there is a loophole, someone will find it. Due to this, we need you to renew your membership with our Club first, then we renew your AWSC membership and then you'll be able to get your discounted trail passes. Our procedure is to turn all renewals in to the AWSC within two working days of our Club meetings or when we receive at least two renewals (this is the minimum required by the AWSC).

OUR GOAL IS TO HAVE OUR ENTIRE CLUB RENEWED BY OCTOBER; this will allow us to submit our entire Club's membership to the AWSC for renewal early in the season. Once the renewals are processed, you will be able to purchase our trail pass(es). So help us obtain our goal by filling out the enclosed application and send it to the address on the bottom or drop it off at September's Club Meeting. We will have additional applications at each Club meeting if needed. Thanks in advance for your help renewing early!
