Before this decision to limit the Fair was made public, our Board had decided not to have our beverage and food tent this summer and just set up vehicles from our major Club sponsors (5 Corners Dodge Chrysler Jeep Ram and 5 Corners Izuzu Truck and Auto) plus signage (Kirchhyan Country Club and our Club) plus snowmobiles and UTVs (Cedar Creek Motor Sports) in the spot where our tent would normally be found. This was due to the many health concerns that change daily in our world today, attempting to staff our tent with enough volunteers to make this work, and will our volunteer efforts be enough to make it profitable. We took a long hard look at our finances and determined if we were to skip our annual fund raiser this summer, we would still be in good shape financially. This even includes purchasing two (2) new tracks for our Tucker (it was recommended to pursue the tracks which have a long lead time as Track doesn't stock them plus we get a good summer discount buying them now while holding off on the extra components as they are readily available).

We have had suggestions of holding other events late this summer or fall to use as a Club fund raiser. Nothing is in stone, yet we will continue to discuss these possibilities and will make them known as we move closer to fall.

So until late August when I will be writing our next newsletter, enjoy your summer off from working at the fair and do your best to get out and enjoy summer as well as staying positive and healthy!
