If anybody knows Dean Wandell from the Germantown Sno-Runners give him a big thank you as he has been making trails stakes. Matt Gazvain provided Dean with 2 big stacks of lumber and Dean cut them down to trail stake length and put a pencil point on them which have been distributed to several snowmobile clubs. We received 480 stakes which are being stored at the Publitz farm so we will be stake ready next fall.

At the up coming meeting we hope to have an update on the Sno-Drifters club and trail system and what we could be looking at this fall. Hope to see you all at the meeting.
